- ❖ Eligible member willing to contest can file their nomination for 2 posts only.
- ❖ The tenure of the managing committee is for two years except Executive President, President Elect and Honorary President, which will be for one year

ELIGIBILITY CRITERIA:

HONORARY PRESIDENT :

- ❖ He/she should be active life member of MAA.
- ❖ No election, to be nominated in the Annual General body meeting.
- ❖ Nomination in honor of their seniority and contribution to MAA and MMC&RI.
- ❖ Seniority by age to be preferred.

EXECUTIVE PRESIDENT /PRESIDENT ELECT :

- ❖ He/she should be active life member of MAA for the period of minimum 5 years continuously.
- ❖ Should have served one term as Secretary / Treasurer/ Joint-Secretary.
- ❖ Should have served one term of at least one year as Vice-President.

VICE PRESIDENT:

- ❖ He/she should be active life member of MAA for the period of minimum 5 years continuously.
- ❖ Should have served one term as Secretary / Treasurer/ Joint-Secretary.

SECRETARY/TREASURER/JOINT SECRETARY:

- ❖ He/she should be active life member of MAA for the period of minimum 5 years continuously.
- ❖ He/she should be the managing committee members for 2 years.
- ❖ If he / she should have 50% attendance in previous managing committee meeting in each term

MANAGING COMMITTEE MEMBER :

- ❖ He/she should be the active life member of MAA for the period of minimum 5 years continuously.
